Amy Gray – NDHS/SDHS Student Services Coordinator – 2025/2026 School Year Elizabeth Hochstedler stated her concern that the position should be filled with someone who is licensed and certified and that it was nothing personal about Mrs. Gray. Nicolas Anderson agreed that this was a valid point. The appointment was approved with a vote of 5-2, with Elizabeth Hochstedler and Nicolas Anderson voting against the appointment.

Public Comment was given by Barbara Lecher. Mrs. Lecher thanked the board for a great 37 years. She also stated that she wanted to educate the board about the scheduling situation. She added that she and Jennifer Bowles personally met with each student in the spring. She also stated that she communicated with Central Office before school was out about the Wednesday schedules and that it was going to require a lot of work. Mrs. Lecher said that schedules had not yet been run and they left the schedules in the best situation and place they could. She also stated that everything was on student transcripts. She told the board that her

contract was until June 30th and that she found it unusual that no one reached out to her and wanted to let the board know they were willing and able to help do anything they could. Mrs. Lecher also stated that there was a situation in which a school board member reported that they were at El Reparo when they were supposed to be at a conference in Indianapolis. She said they were at the conference and had letters and video showing they were not at El Reparo. Mrs. Lecher stated that there is a lack of communication and transparency. She said that no one from Central Office reached out to congratulate her on her retirement.

There was nothing under Old Business.

Under New Business, Mr. Ernie Ruble and the NDHS State Academic Teams were recognized. Mr. Ruble was joined by student Cletus Rennekamp. Mr. Ruble stated that they have had two really strong years. Last year they received state runner-up in social studies. This year they were state finalists. This year's team consisted of Jessa Wagner, Breanna McBride, Lillian Gardner, Cletus Rennekamp, Vanessa Apostolakos, Alexandria Apostolakos, and Kay Aug. Mr. Ruble explained that all five teams of science, fine arts, social studies, math and English scored high enough that the combined score got them into the state interdisciplinary championship. The state championship team consisted of team captain Jessa Wagner, Gabby Adams, Jenna Richardson, Breanna McBride, Alex Tebbe, Jacob Gearhart, and Dorothy Robbins.
